**Special Conditions :**

1. On arrival in New Zealand samples may be inspected by an MPI Inspector as described in section 1.9 of the import health standard MPI.STD.PLANTMATERIAL.
2. The quantity of individual samples imported under this permit may be up to 2.5 kg per consignment.
3. All samples must be clearly labelled and consigned in secure packaging. On arrival in New Zealand all documents associated with the consignment will be inspected by an MPI Inspector.



4. The importer must keep a record of all samples introduced under this permit (including scientific name/description, country of origin, date of arrival) and the current status of the material (i.e. held/in use/destroyed). Upon request, this record must be made available to an MPI Inspector at any reasonable time.
  5. The samples must be stored and used at the transitional facility in accordance with the facility's quality operating system, and must not leave the facility without further authorisation from the facility inspector.
  6. Material imported under this permit is for analysis only. No microorganism enrichment, isolation and/or culture is permitted on any of the products imported under this permit, and no plant material is to be propagated from any of this material or its derivatives.
  7. No viable microorganisms are to be extracted or reconstituted from any of this material or its derivatives.
  8. Any material remaining after analysis must be incinerated or autoclaved for disposal, unless otherwise stated in the operating system with further authorisation from the facility inspector.
  9. If any conditions of this permit to import cannot be or are not complied with, the importer may be required to reship or destroy the material.

## **IMPORTANT INFORMATION FOR PERMIT HOLDERS AND AGENTS**

- 1 This permit, and compliance with the provisions of the specific import health standard(s) and/or entry conditions, does not guarantee that the goods you import will be given biosecurity clearance. There are other restrictions in sections 27 and 28 of the Biosecurity Act 1993 which apply to the giving of biosecurity clearance. - 2 You will need to ensure that the goods you import comply with the provisions of the specific import health standard(s) and/or entry conditions that are applicable. The import health standard may be amended during the course of your permit. Import Management will notify you of any significant changes to the import health standard and will re-issue the permit to accommodate these changes.
- 3 There are a number of other provisions in the Biosecurity Act 1993 which may affect you. If you commit an offence against the Biosecurity Act 1993, heavy penalties under section 157 of the Act might apply.
- 4 Apart from the Biosecurity Act 1993, there are other laws relating to or prohibiting the importation of goods. This permit, and compliance with the provisions of the specific import health standard(s) and/or entry conditions, does not absolve you of the need to comply with these laws.
- 5 Unless specifically identified in 'Description of Items' or 'Special Conditions' of the permit, NO new organisms, including genetically modified organisms, are permitted entry under this permit.

- clearly labelled with the scientific strain and name
  - consigned in leakproof packaging
  - free from contaminants
- 7 All new organisms must not be opened until received by the nominated containment facility.
